Information

 - The call for speakers focuses exclusively on the applied stream
 - The applied stream puts special emphasis on how data and AI use cases can be scaled successfully in organizations
- Standard length of presentations will be 15 minutes

 - **providers who present together with a customer or**
 - **industrial users.**

Size & Content

- The abstract is limited to a maximum of 2,000 characters incl. spaces
- The title should be short and meaningful (max. 100 characters incl. spaces)
- The abstract should outline the problem, describe the solution, explain the practical value and underline its relevance, e.g. to customers, the data and/or AI eco-system or the industry
- A strong focus of the summit and thus an important factor for abstract evaluation is the submission's relevance to practical applications. Therefore, contributions presented together with a client or partner are preferred. Please also note that the AI & Data Summit is not well-suited for marketing presentations.

Review & Registration

- Notifications of acceptance or refusal will be emailed to the presenters after the reviewing process
